Introduction

You can renew your existing KPMG subscriptions at any time, by clicking "Manage Services" in the "Services" session.

The renewal must be done in the last month before the service end date at the latest. If you have appointed a Fiscal Representation in a country (for VAT compliance) or a VAT intermediary (for IOSS compliance), you must renew two months before the service end date.


Failing to renew on time may result in a delay in submitting your returns (which could lead to penalties) or de-registration (especially for IOSS).



When to renew your VAT Compliance service

You will start receiving pop-up messages 60 days before the service end date every time when you log in; here you can start the renewal process by clicking on "Renew Services":

You will also receive a weekly reminder email starting from 60 days before the service end date:



If you click on "Renew Now" in the reminder email, it will direct you to the following page:




Login and select "Renew Services" from the pop up.




Select the countries that you would like to renew. You will see the expiring countries listed on the top.

You can add new countries now. The other countries will be listed below.


You can reach this page without the pop up message as well: go to "Services" then select "Manage Services".







IOSS service is listed separately, either on the bottom of the page (if you do not have an active IOSS subscription), or at the top (if you have an active IOSS subscription that you wish to renew):






Click "Next"; here you can choose additional services (if applicable):




Click "Next", and check the order summary and select the payment method:






Click "Download Contract" and tick the two boxes below to accept the Contract and agree with the terms, then click "Confirm order" to proceed:






Payments via PayPal will be processed immediately. If you choose to pay by bank transfer, you can find our bank details as on the previous page (or upon request) after you click "Bank transfer".

You can check the status of your payment under "Order History":






Click "Upload proof" to upload payment proof for the bank transfer:





Once the transfer is made, our finance team will check the payment and proceed with your subscription usually within 3 working days, then you can see the payment status will change to "approved", which means that your renewal is completed:



Please select "I don't want to renew" for the countries where you don't want to renew your subscription - from the pop-up message:






How to decline one or more renewals

Select a main reason to decline whichever renewal(s):




Select a sub reason then click "Save" to finalize it:





How to decline one or more renewals

If you select "I plan to stop trading and de-register for VAT" then please contact your account manager about the de-registration process and fees. Please note that you may be required to extend the services and continue submitting VAT returns until the de-registration is completed.



Click "Save" to finalize it.




If you miss the renewal deadline

If you do not renew a service before the expiration day, it is **deemed to be cancelled by you** and we will inform the tax authorities that we no longer represent your business.

If you did not renew, you can still decide to come back to us in the future. We will onboard you as a new client again; which means that you will have to fill in our questionnaire on the portal and you will have to sign some documents.

You can sign up for expired countries at "Manage Services" under "Services"





If you miss the renewal deadline

You will see the expired countries on the top of the page. You can select them now:

If you miss the renewal deadline

You need to let us know if it is a late renewal for this country, or you are returning to us from an other service provider after a break.

Extend by one year: your subscription will be renewed by one year, starting from the original expiration date. Select this if you forgot to renew in time.

Restart Compliance: you are signing up as a new client who is coming back to us from an other service provider. You need to add a start date if you select this option. Your subscription will be valid for one year starting from the date provided by you.
